- Parking in Culgaith was raised again. It was resolved that as this is included in the Annual Report, which is going to every house hold we will hopefully see the situation improve.
- Street Lighting is to be reviewed again. 18 June 2015 an audit will take place. It is hoped Sheila Orchard along with Parish Council representatives from each village will attend.
- The condition of the notice board at Skirwith was raised. It was confirmed that this was not the Parish Council one, which is the one inside the bus shelter.
- The road from Skirwith into Langwathby has some bad subsidence causing damage to vehicles should they pull off the single track. Cllr Jill Hay **agreed** to contact highways as she has good contacts within the department.
- It was also noted that a skip had been on Blencarn green for a long period of time, without permission. It was **resolved** that a letter would be addressed to the owner. **Post meeting note:** It was reported to have been

moved 15.5.15, no letter was required.
