22.3 Skirwith Footway Lights – The light opposite Skirwith Village Hall and the one in front of Pear Tree house. EDC had reported that the electrical connection issue was still with Electricity N W. The Parish Council had requested a supply and maintenance refund in respect of both lights. The matter is ongoing.

22.4 Queens Platinum Jubilee

- **22.4.1 Cross Fell Beacon**. It was confirmed that due to SSSI issues, a Beacon on Cross Fell would not happen.
- **22.4.2 Platinum Jubilee Tree**. It was agreed to plant a Parish Platinum Jubilee tree in Culgaith in consultation with the Guardians of the Tarn. A plaque to be purchased –

22.4.3 Blencarn Platinum Jubilee Tree. Councillors confirmed that they had no objection to Blencarn Village Hall planting a Platinum Jubilee tree on an unmown part of Blencarn Village Green. It being confirmed that the landowner, Blencarn Hall, were in agreement. The cost being covered by Blencarn Village Hall.

22.5 Parish Tree Safety Maintenance Work Required – 2022.

It was reported that tree safety maintenance was required in Culgaith and Kirkland, costing £200 each respectively. It was unanimously agreed to instruct Dave Willetts to complete the work.

22.6 Beck Cottage Skirwith Essential Tree Maintenance Work Required.

It was confirmed that two trees adjacent to this property, on the Village Green, required essential maintenance. The roots of one were impinging on a property wall, necessitating the tree to be felled and the stump killed. The other required pruning as branches were touching overhead telephone wires. Two guotes for the work had been obtained, copies being on file.

It was unanimously agreed to place the work with the Council's existing contractor, Dave Willetts, at a cost of £800. The work to be carried out in the autumn.

22.7 Blencarn Village Green Steep Track Repair. -

It was reported that the short, steep incline on Blencarn Village Green, outside of Orchard Cottage, was badly eroded and required leveling and resurfacing. The Village Green landowner, Blencarn Hall, were in agreement for work to be done; it being custom and practice for the Parish Council to

undertake this maintenance.

22.8 Road Safety Issue - Culgaith to Temple Sowerby Surgery. -

A Parishioner had raised safety concerns regarding pedestrians walking along the A6214, from Culgaith towards Temple Sowerby, en-route to the Temple Sowerby Doctors Surgery. A request being made for a roadside footpath to be install alongside the A6214 and consideration being made to create a footpath, across fields by accessing S 106 funding.

It was reported that the above request had been forwarded to Cumbria Highways for their consideration. The following response had been received: -

"To construct a footpath within the confines of the highway boundary, on this road is not possible due to available road/verge widths, regardless of any funding constraint.

Regarding funding, such schemes are deemed 'Highway Improvements' and are approved and funded via the 'Eden Local Committee – Budget'. The cost of such a project, to create a roadside footpath on this section of road would be estimated to be in the region of £250,00. As the total budget, for the whole of Eden District, for 2022/23 is only £25,000 the funding of this request is totally out of the question.

Regarding S106 funding; this is money received from developers to provide 'Safer links', however, **such funding cannot be applied retrospectively** and there were no S106 conditions linked to the planning approval for the Otters Holt and Hazel Dene developments, further, a project of this cost could only be considered when linked to a very large development.

With regard to footpaths.

Looking at the footpath map nothing directly links Culgaith to Temple Sowerby, though there is a footpath, west of Millrigg', to the Temple Sowerby Village. I am uncertain of the condition of this path, but it is out with Culgaith Parish. To create a new, registered footpath, across private land, is extremely problematical and past County experience is that it is nearly impossible to achieve."

Cumbria County Council Highways.

A number of sites in Culgaith were submitted as potential housing sites, some have since been developed; however, the site in question was assessed and discounted as unsuitable in 2015 as part of the development of the Eden Local Plan 2014-2032

Further, the target number for housing in Culgaith was defined as 49 in the Local Plan but the number projected to be built is 74, this being 25 over the target.

The above is the current position. The Parish Council's assessment of the situation is that should the owner of the field in question ever decide to apply for planning permission in the future, the above points would strongly go against permission being granted.

Whilst it is not possible to speak for a future Culgaith Parish Council, one could make an assumption that in the circumstances the Parish Council would be minded to object to such a development. The Parish Council is not aware that this site has changed hands and is not aware of any current plans for its development; that said, in planning matters, you can never be 100% certain of future decisions.
