57/22 Minutes

The Chair was unanimously authorized to sign the minutes of the meeting of the Parish Council held on Monday 5th September 2022, as a true record. Proposed by Cllr P Toppin Seconded by Cllr D Witney.

58/22 Declaration of Interests

There were none.

59/22 Public Participation

It was reported that a foot path, finger post, was down by the Chapel, on the path to the 'Back Road'.

61/22 County Council Report – Cllr Claire Driver.

1. Presentation by care lavers: We had an excellent presentation by two of our care leavers t full council last Thursday, talking about the work they have been doing to refresh the promise all Councillors make to our looked after children in our roles as corporate parents. Strengthening and highlighting this crucial role is timely as we move into the new Unitary Authorities next year.

2. Cuts in local radio: The Leader of the Council made a statement and wrote to the Government in opposition to the proposed cuts to local radio which councillors may be aware of, and which would mean the end of Radio Cumbria and any specific local coverage.

3. Postponement of the decision on the coal mine in West Cumbria: Once again this has been kicked into the long grass by the government at the eleventh hour. An impassioned plea was made by the local member to hasten the decision, and out and end to the uncertainty for the local and wider communities in Cumbria.

4. Cost of living crisis support: A new coordination group has been formed (chaired by Colin Cox), bringing together local gov, NHS, 3rd sector, local resilience groups. This group will be in existence throughout the coming winter to make the best use of available resources, and try and avoid duplication. 5. Care sector: Huge concerns about the care sector and its ability to cope through the coming winter. We're already working in crisis mode trying to fill vacancies across Cumbria Care, which is already under incredible strain. The closure of a care provider at incredibly short notice placed additional pressure on Cumbria Care, as

yet again local government had to step in and prop up the private sector. Although recent announcements by central government

seem to suggest that they have allocated funds to support the failing health and care sector, we have yet to see even a penny of this funding distributed.

6. Cost of children's care packages continues to increase, a recent care package for example is costing the council £10k p/w, which is not unusual now. This is a complex topic so for any councillor wishing to find more detail, please refer to page 26 of this month's full council papers, CLA (children Looked After) placements sufficiency Strategy.

7. Financial Strategy - half yearly review: In spite of the relentless financial pressures that the County Council is operating under, we continue to delivery within our financial strategy, thanks in no small part to our excellent finance team. At last week's council meeting the council unanimously agreed to note the successful delivery of the half year financial strategy review. A great deal of previously allocated funding has had to be ring-fenced or re-profiled in light of LGR, meaning that some previously identified projects may not be delivered within this financial year. I have no fine detail on what this might mean for our area, other than to say that the likelihood of getting any new projects identified and delivered is slim to none, unless they are required from a safety point of view.

62.7 Budget 2023 – 2024

A draft 2023/2024 budget was tabled for discussion. It was noted that a 6.5% inflation rise had been built into the calculation, this possibly being conservative. A further point was that, with the Parish Council having to bear the full cost, should there be an election in the Parish in May 2023, a figure of £1000 had been included; this being 50% of the £2000 CALC had recommended. These economic realities were putting great pressure on the Parish Council's finances.

In the current 'cost of living' crises Councillors were reluctant to raise the Precept to cover this extra expenditure, however, not to do so would result in the Council incurring an approximate, £2300 budgeted deficit at the year end. Taking into account the Councils current asset value it was felt that the Council could bear such a deficit, for this year at least.

The budget was unanimously approved leaving the Precept, as last year, at $\pounds12000$.

64.1 Foot path signs

Kirkland/Broats - Bramblelands/Barn Croft - Station Road to Culgaith Church. Footpath signs down. Action still awaited from Highways.

- **64.2 Culgaith Entrance Road Signs and Road Markings** Signs agreed by Highways – Awaiting installation.
- 64.3 Drainage issue by the Beck Mill entrance. Situation still being monitored.

- Action :- To take the issue up with EDC Portfolio Holder. Cllr Mike Tompkins64.10 Fir Tree 1 Station Road Felling and killing of stump.

- **64.11** Skirwith Village Green Roadside Boundary Fence. Reported that Highways had scheduled the work to be done in November '22
- 64.12 Beck Cottage, Skirwith Revised Driveway Deed of Grant. In hand.
- 64.13 Electricity NW Tree maintenance in Church Street Skirwith. Work agreed but waiting to be done.
- **64.14** Eden Speed Limit Review Culgaith. Reported that the request to introduce a 40mph limit from the Newbiggin junction to the current 30mph sign, before the school, had been rejected on highway legal grounds. It was, however, confirmed that the previously agreed new 30mph sighs would be installed. The work having been placed with contractors.
- 64.15 Commemorative Tree to our late Queen Kirkland. Permission had been sought for this tree to be located on Kirkland village green.
 Action: Agreed to cover the cost of the tree with Cllr K Philipson agreeing the location with Parishioners.

- **65.1 40 Email** had been forwarded to Councillors since the September meeting.: kept on file for 12 months.
- 65.2 Dalefoot Compost at Blencarn Hall Farm. Planning Issue

The following correspondence had been received from Blencarn Hall Farm, Blencarn, which was requested to be read out at the meting and made public, in order to clarify the planning situation regarding the Dale Foot compost business, based at Blencarn Hall Farm

"I am writing to Culgaith Parish Council, so that I can ask you to put on record recent events concerning our farm. I am happy for this email to be read out at the forthcoming Parish meeting on 7 November 2022.

Earlier this year a resident of Blencarn raised an 'enquiry' with Eden District Council ("Eden") concerning activities on the farm. Essentially, a complaint. Specifically, Eden was asked to consider whether those activities amount to any change of use to the established existing agricultural use, which has been at the heart of the village for a very long time.

We received a letter outlining the complainant's concern which gave rise to a meeting at the farm on 24 June 2022 with Eden planning officer Kath Joynt - attended by my wife Helen and *I*, our land agent Thomas Armstrong of H&H and Simon Bland, director of Barker & Bland Limited - who crop the land and occupy the buildings.

At that meeting it became clear that the complaint had been initiated by someone unfamiliar with the usual ambit of agricultural activities and still less of the history of the farm and the village as a whole.

Following the meeting, Eden made it clear that they saw no planning issues at all. I attach a copy of the email we received from Eden which made this clear and which I understand was communicated to the 'enquirer'.

In the past couple of weeks, a further complaint has been lodged by the same person, of whose identity we await confirmation. We have again been contacted by Eden and this has led to a further meeting, this time with Pam Joyce who is Eden's Principal Planning Enforcement Officer in addition to Kath Joynt.

I should make it clear that there has been no change in activities, except that things are quieter as winter approaches, as you would expect.

That second meeting was held last week, again attended by me and Mr Bland. The outcome was the same as previously, in that the Council officers expressed the view that there was nothing of concern. I am awaiting confirmation of this by email and will forward this once received.

Please can you put this fact into the public domain via your meeting, so that everyone is aware of Eden's view.

This situation is disappointing because:

- the complainant has not seen fit to approach us directly with any concerns, preferring instead to seek anonymity in making contact direct with Eden; in a small community like ours, I would expect those with something to discuss would initially talk to us;
- 2. the nature of the complaint requires us to involve our tenant and our land agent, expending (and wasting) time and money.

Therefore, please can you make known the fact that Eden have confirmed that the current activities at the farm are lawful and within the established use for planning purposes.

If anyone living in Blencarn has any issue relating to the farm, then they should please raise it with me, as I have day to day responsibility for the management of the farm.

On a more serious note, if another complaint of this kind is made without reasonable cause, then we will consider what step to take to protect our position."
