#### 68/23 Minutes

#### 70/23 Public Participation

**70.1** The Secretary of the Victoria Institute, Culgaith reported to the meeting that the Victoria Institute had a new and active committee. Plans had been drawn up to include some of the following improvements: - To upgrade the insulation of the building, including the installation of double glazing, to install a lift and to improve the disabled access; the total projected cost being in the region of £90,000.

Advice was sought for possible sources of funding.



**70.2** A Parishioner raise the issue of there being no footpath sign by 'Tarn Villa. The meeting reported that the Council had been in correspondence with, formally Cumbria County Council, Highways Department over this matter for the last three years, and latterly with Westmorland and Furness Council.

The formal position of the registered the path had recently been confirmed by Westmorland and Furness Council. This 'Registered Right of Way' (green) is routed

very near to dwellings and an unofficial route (red) has been created across fields, nearby to avoid inconveniencing properties. This revised route has been used for a number of years without objection. (See map below)



Westmoreland and Furness Council have confirmed they can only signpost the Registered Path, which is currently not in use, and cannot signpost the unofficial diversion. To erect an official Registered Footpath sign would, therefore, point in a different direction to the currently used, unofficial, path and would be in an inappropriate location. To do otherwise would lead to people wrongly assuming the diversion at this end of this path is a Registered Public Footpath; this is not a problem at the other end of the path adjoining the 'Back Road'.

A pragmatic way forward would be for the landowners, over whose land the unofficial diversion passes, to formalise this route as a 'Permissive Path'. This then could be signposted accordingly.

**Action:** - Councillors unanimously agreed to investigate what was required, including the legal and insurance implications, to formalise this unofficial diversion as a 'Permissive Path'.

## 74.10 Flooding Issue

The Pea to A6412 Junction – Drainage issue.

This flooding issue had been reported to Highways again.

## 74.11 Culgaith Tarn Boundary. – Not Stock Proof.

It was reported that the Parish Council was now in possession of the contact details in respect of the the Land Agent managing the adjoining field and the person grazing the land. Both had been notified of the problem being experienced with sheep escaping onto the Tarn Field, with a request made that steps be taken to avoid it happening in the future.

It had been confirmed that this boundary wall was not the responsibility of the Parish Council.

## 74.12 Staingills/Off Back Road, Culgaith – Erection of New Farm building.

It had been confirmed by WAFC Planning Services that no permission was required to erect this new agricultural building. It relates to Prior Notification Application 23/0153.

This was a Prior Notification application type, the applicant being required to notifying Planning Services that they wished to carry out the development under permitted development legislation -Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) - Schedule 2, Part 3, Class Q.

As such Planning Services were not required to consult with the Parish Council. Had the planning officer refused the application and deemed that the application did not fall within permitted development, then they would have requested that a full application be submitted and the normal consultations for this type of application would then have been carried out.

## **74.13** Skirwith Bridge Area – Sapling growth.

Reported that the matter had been attended to.

## 74.14 Culgaith Drove Road – Demolished Bench

It was reported that this bench had been hit by a vehicle and had been irreparably damaged.

The bench had not originally been provided by the Parish Council, nor was it on Parish land. That said Councilors were minded to finance a replacement as it was a community asset, well used by those walking the Culgaith Back Lane; if so done, a replacement bench could be added to the Parish Council's Asset Register and covered by insurance.

The estimated cost of a replacement recycled plastic bench, 1.5m long, being approximately £360 + Vat, plus fitting costs.

Action:- Unanimously agreed to replace the bench providing there was no objection from the land owner, this being assumed to be WAFC Highways.

**74.15** Blencarn Green – Silver Birch on Village Green by Cobblestone Barn Concern had been raised by two parishioners over the height that this tree had grown to. A quote to prune had been received of £250.

Action:- Unanimously agreed to prune, to lower the height, at the quoted
