22/0362 – Land Northeast of Culgaith Primary School, Culgaith. - Erection of 5 dwellings including associated operations. The meeting was informed that this long standing and controversial application was being put before the Planning Committee on Wednesday 15TH January. Cllr S Smith would be present to inform the Committee of Culgaith Parish Councils strong objection.

9/25 Willan Living – Community Land Gifted to the Parish Council at Otters Holt.

Reported that the conveyance, regarding the transfer of ownership of this ground, had been completed on the 15th November 2024

10/25 Otters Holt - Community Land Management Plans

- **10.1** Following an Informal Consultation with some residents at Otters Holt it had been suggested that the provision of a Defibrillator, bench and notice board would be appreciated.by those living on the estate.
- **10.2 Defibrillator** Reported that a grant application for a fully funded Defibrillator and Cabinet (approximate value £2120) had been submitted to the British Heart Foundation.; a decision was awaited. It was also reported that permission had been sought, but awaited, from Electricity North West to locate the Defibrillator Cabinet on the Electricity sub-station wall. The owner of a property, adjacent to the sub-station, had, public spiritly, agreed for the Cabinet to be wired into his property (quoted cost £300 + Vat) with the Parish Council covering this cost and also the annual electricity costs. (approx. £13)
- **10.3 Bench** The meeting was presented with a quote of £380 net for the provision of a black, recycled plastic, two-seater bench, with fixings. A parishioner had, kindly agreed to install it, at cost. It was unanimously agreed to proceed with this purchase. Cllr lan Stowers would confirm the exact location.
- **10.4 Notice Board** As requested at the previous meeting, a quote had been sought from a local joiner to make a bespoke notice board. Regarding this suggestion, the opinion of the local joiner was that after taking into account labour and material costs, quality hard wood timber being very expensive, it may be a more cost effective decision to purchase a board from a professional company.

Quotes had, subsequently, been sought from a reputable and competitive company Signscape and Signconex.

Following discussion, it was unanimously agreed to purchase the 2 x 670W X 931H Double Door, Board, at a total cost, including delivery, of approximately £1514.

It was agreed that the ideal location would be in front of the electricity sub-station wall.

- 11/25 'Fibrus' FFTP Overhead Installation Culgaith.
 - **11.1 Markus Campbell-Savours MP –** Was contacted, as requested, outlining all the concerns and issued raised, regarding this issue, as recorded in the 4th November minutes; a copy being sent to 'Fibrus'
 - **11.2** 'Fibrus' Response' A response was received from 'Fibrus' immediately, as reported below:-

Stating that they were investigating why their contractor had submitted an application to install 17 poles in Culgaith. This was because, as it currently stands, 'Fibrus' are not contracted to deliver a full fibre broadband network in Culgaith. It being assumed, that this is because another supplier has indicated that it intends to deliver full fibre in the Culgaith area, namely 'Voneus'.

'Fibrus' suggested that as 'Voneus' has already delivered full fibre to only parts of the Parish and has recently written to other residents to withdraw its interest in extending the network to other villages, CPC may wish to forward a copy of this correspondence to Markus Campbell-Savours MP and ask him to share it with BDUK (Building Digital UK) to let them know that the previous commercial interest in your area has now fallen away.

As part of the **Hyperfast GB Project**, 'Fibrus', via its contractor, 'Viberoptix', is surveying all 60,000 properties in the '**Project Gigabit Programme**' in order to provide a view of delivery and implementation cost, should those properties be brought into the **Hyperfast GB Project**. This work helps 'Fibrus' to respond, in a timely manner, to any requests to add more properties to the **Hyperfast GB** contract.

It is suspected that 'Viberoptix' has issued the pole application as part of this survey work. For example, if 'Fibrus' were to build in the village, either to connect properties in the village or to get their network through the village, to properties beyond, then the final design of that network would depend on responses received to the statutory 28 day consultation, 'Fibrus' submits to Highways for infrastructure on public land. To that end, the application forms part of the survey process. **There is currently no sign-off for these poles to be stood.**

It is strongly recommend Culgaith Parish Council make a response to the Highways consultation to raise its concerns, as has been done, to your MP. That response will be considered by the 'Fibrus' planning team when developing the final design, should 'Fibrus' be contracted to deliver to properties in Culgaith in the future.

- **11.3 Markus Campbell-Savours MP** responded by forwarding to the Parish Council a copy of the response that had received by the Parish Council, from 'Fibrus'
- **12/25** Kings Portrait Culgaith C of E School It was reported that the school had greatly appreciated the gift of the portrait, it was now proudly hung in the main hall, being a focal point to raise awareness of the Monarchy.

13/25 Highways and Land Matters

13.1 Pedestrian Hazard - Black Swan Junction, Culgaith.

This issue had been raised with Highways and they were assessing what, effective, action could be done to improve safety, a possibility being to improve road markings. It being recognized that this was a 'tricky' corner with no spare space to make road improvements. A response is now awaited.

On contacting the Police, they had responded by saying that the public could assist by reporting any dangerous incidents to them on Tel No. 101, giving details of date, time, registration number and a photograph of the incident. They would then follow up the matter.

13. 2 Skirwith – Church St. Roadside Concrete Post and Rail Fence Repair. Reported, as previously, that this in hand with Highways and will be actioned when

funding is available.

13.3 Drainage issue - The Pea to A6412 Junction

Still in hand with Highways.

13.4 Flooding Skirwith – Between Blencarn Junction and Skirwith Reported to Highways.

- **13.5** Broken Manhole Cover Skirwith/Langwathby Verge. Repaired.
- **13.6 Mill Cottage, Blencarn –** Drains requiring jetting. Reported to Highways.

13.7 Damaged 'Give Way' Sign – Blencarn to Skirwith Junction.

Reported that a request had been made to Highways to repair the sign and also to re-paint the road marking.

14/25 Schedule of Correspondence, Notices and Publications.

The following item of correspondence was received since the last meeting.

14.1 Forwarded E Mails to Councillors – 29 since the 4th November meeting. Kept on file for 12 months.

14.1 Sat Nav Mapping Clarification

Reported that a response had been made to a Parishioner's correspondence, clarifying the level of detail shown on a Sat – Nav programme. The cheaper programmes showing little detail and not indicating carriageway weight limits with the very expensive programmes including a wealth of data, including weight limits.

14.2 Culgaith Recycling Site

Reported that a response had been made to a Parishioner's correspondence, regarding the tidiness of the Culgaith Recycling site. It being clarified that this area was not the responsibility of the Parish Council, but that of Culgaith Village Hall Committee, to whom correspondence should be directed.

14.3 WAFC Lighting Policy

It was reported that WAFC were undertaking a major review of the Authorities Footway and Highways lighting policy. A report being expected later in the year.

14.4 Community Led Planning Initiative – ACT
