19/11 APOLOGIES

Councillor Findlay (family illness). **Resolved** that the apology be noted and the reason approved.

20/11 MINUTES

Resolved that the Minutes of the Meeting held on January 10th be signed by the Chairman as a true record.

21/11 DECLARATIONS OF INTEREST

Councillor Hay as a Director of the Fellrunner, and Councillors Helm and Richardson as Trustees of the Kirkland and Blencarn Recreation Room in Item 26/11 Grant Applications. The Clerk, as Chair of the School Governors, declared an interest in Item 31/11 Culgaith School.

22/11 PARISH CLERK'S REPORT on matters since the previous meeting

- Based on the feedback from Parish Councillors a submission had made to the County Council on its Budget Priorities for 2011/12.
- The Boundary Commission had confirmed that having considered all the responses to its initial consultation on the most appropriate number of councillors for the County Council, there had not been sufficient evidence on which to base a decision. Further discussions were to be held with the County Council.
