**41/09 DECLARATIONS OF INTEREST**

- Councillor Wilson declared an interest in Skirwith Village Hall under Item 45/09 Planning.
- It was noted that Councillor Slann is no longer involved with the Guardians of Culgaith Tarn.

**42/09 PARISH CLERK'S REPORT on matters since the previous meeting**

- Public Right of Way by Culgaith Church, around Wellgates Cottage and into the field. Cumbria CC had confirmed verbally on 24<sup>th</sup> April that the application is due to be considered at a committee meeting on July 28<sup>th</sup>.
- The work to repair the wall at the top of Skirwith Village Green had been completed in early April.
- The Grass Cutting Contract had been awarded to Mark Hill Grounds Maintenance after they had given a written assurance that they had visited all the sites, including Skirwith, before submitting a tender.
- The Fellrunner, The Guardians of Culgaith Tarn, Kirkland and Blencarn Recreation Room, Skirwith Village Hall, Culgaith Victoria Institute, The Memo and Culgaith PCC had all written to thank the Parish Council for its recent donations and support.
- Cumbria Highways had been notified that the grit bins need filling.
- The problem of the blocked drain on the Tarn had been reported to Capita.
- The Cumbria CC meeting to review the Winter Gritting programme for 2009/10 is scheduled for September and the Clerk will write again before the meeting about the need to grit the Skirwith – Culgaith road.
- The Countryside Ranger had inspected the footpath through Hag Wood in Culgaith and repairs to the walk way had been scheduled for 2009/10.
- The litter bin by Culgaith Victoria Institute had been replaced with a bigger one.
- Cumbria Rural Housing Trust had published draft plans for conducting housing surveys. Culgaith Parish is scheduled for 2010.

#### **Skirwith Village Hall**

**Resolved** to support Skirwith Village Hall by submitting a planning application on their behalf to bring the hall up to modern standards and improve the internal usage and environment by refacing the external walls with an insulated cladding system, installing photo-voltaic panels on the south facing roof and constructing an for storage. EDC had confirmed that if the Parish Council applies the fees would be reduced by 50%, the cost to the Parish Council would be £85.

At the Annual Parish Meeting on April 27<sup>th</sup> Derick Cotton had been invited to talk about the Bolton Exchange, which brings the local community together on a weekly basis for coffee with a book stall and stalls selling local produce. The project had generated a great deal of interest and a group of people were planning an inaugural coffee morning on June 20<sup>th</sup> to see if a similar scheme could be started in Culgaith. **Resolved** that the Parish Council should provide support by funding the cost of flyers promoting the event.
