MINUTES OF THE PARISH COUNCIL MEETING

49/10 APOLOGIES

Councillors J. Findlay (holiday), E. Froggatt (work) and H. Roper (work). **Resolved** that the apologies be noted and the reasons approved.

50/10 DECLARATIONS OF INTEREST

Councillor Wilson in Item 54/10 Planning Application 10/0311 Skirwith Hall, Skirwith. Proposed agricultural building.

51/10 PARISH CLERK'S REPORT on matters since the previous meeting

- Carl Glynn of ACT had accepted an invitation to come to the July meeting to talk about updating the Community Action Plan.
- The topics chosen by Parish Council had been submitted to the 2010/11 Scrutiny Work Plan
- The Kirkland and Blencarn Recreation Room, Skirwith Village Hall, The VIC, The Fellrunner, The Memo, and Culgaith PCC had all written to thank the Parish Council for the grants of money and its continued support of their activities.
- The Guardians of Culgaith Tarn had emailed the Parish Council to thank it for taking back responsibility for cutting the grass at the front of the Tarn.
- A printer/scanner/photocopier had been purchased for the Parish Council.
- The Clerk now had access via Internet Banking to the bank account to monitor transactions.
- PC Taylor had reported that a member of the public had complained about dog fouling in Culgaith. Notices had been put up on the lamp posts and Notice Board. The Community Warden had been alerted and would continue to monitor the situation.
- Skirwith Village Hall had written to thank the Parish Council for its support for Phase 1 of the renovation project.
- The Highway Steward had the paint to repaint two signposts in Culgaith and it was hoped this would be done on his next visit.
- Cumbria Highways had sorted out the problem of water running down the road in Blencarn where it forks to Skirwith and Howrigg.
- Cumbria Highways were looking into the problem of Kirkland Beck encroaching on the road at Kirkland.
- Cumbria Highways had confirmed that the dip in the road by Millrigg will be resurfaced in the coming year.
- Network Rail had inspected the road by the level crossing and had advised that the responsibility lies with the Cumbria CC. The County Council had confirmed that this part of the road will be repaired when the road is resurfaced later this year, but it will require Network Rail's permission as it affects the level crossing.

52/10 CHAIRMAN'S ANNOUNCEMENTS

53/10 PUBLIC PARTICIPATION

- The Chairman of Culgaith Victoria Institute Committee reported that there was now a rota of people who were willing to keep the Recycling Centre clean but fly tipping was still a problem.
- It was also reported that there would be no flowers around the Culgaith War Memorial or Victoria Institute this year due to vandalism.
- Concern was raised about large stones which had appeared outside 1 and 2 The Greens Culgaith, making it difficult for vehicles and pedestrians to pass when there was oncoming traffic.

The Clerk was asked to report the problems associated with fly tipping and vandalism in the report of the meeting for the Memo. The Clerk was also asked to write to the occupiers of 1 and 2 The Greens about the boulders.

58/10 COUNTY, DISTRICT COUNCILLORS AND POLICE REPORTS

No reports from the County or District Councillors but both had attended the Annual Parish Meeting on April 26th. PC Taylor had sent her apologies and an update by email. The main problems were hare coursing, pick pockets in the local pubs and the theft of sheep. The main priorities were drink drivers.

59/10 WINTER GRITTING

Tony Markley the Portfolio Holder at Cumbria CC had responded to the Parish Council's letter requesting that the school bus/taxi routes were added to the winter gritting programme. He recognised that the east side of the County had faced some severe weather during the winter. The School had supplied evidence of the number of days when children from Kirkland, Blencarn and Skirwith had been unable to attend school and this had been passed on to the County Councillor. The Chief Constable had asked Chief Inspector Greenhow, Uniform Operation Support to look at the issues raised by the Parish Council.

Cumbria County Council Local Committee for Eden had met in April and had recommended that County's Cabinet upgraded the gritting routes for the roads from Culgaith to Skirwith and Blencarn. The Cabinet will meet in July.

6010 HOUSING SURVEY

Cumbria Rural Housing Trust had reported that as of 10 May there had been a response rate of 38.12%. Jayne Potts had accepted an invitation to report the findings at the July meeting.

61/10 FLOWERS ON THE FLODDER

Resolved not to accept a local resident's offer to plant snowdrops and daffodils on the Flodder given the long problematic history of this village green.

62/10 LITTER PICKING

Resolved that the Clerk should contact Eden District Council about the litter in the parish and particularly on the road between Skirwith and Culgaith.

61/10 CORRESPONDENCE

The Chairman reported that a letter of resignation had been received from Councillor Froggatt who was moving out of the area.
